PRESIDENT'S REPORT

Pam Saunders reported to the board about correspondence she received concerning alleged incidents of unsportsmanlike conduct occurring after the conclusion of the 2017 NCA National Specialty by an exhibitor.

John Cornell moved and Pam Rubio seconded to entertain the executive session business. The board adopted the motion without objection. The board reported following business from the executive session:

For the period of March 20 – May 4, 2017, Treasurer Mary L. Price reported a net loss of \$18,557.23. She also reported a cash balance as of May, 4, 2017 of \$176,960.47.

SPECIALTY SHOW COORDINATING COMMITTEE

Robin Seaman joined the meeting. She updated the board about concerns that have developed about the condition of the turf at Heritage Park at the Frankenmuth show location due to other lessees' use. After exploring other options at the site, the Specialty Show Coordinating Committee recommends plans to relocate the ring in the southwest corner of the grassed Herzog Platz Area. The Committee is also working on contingency plans to move the dog show indoors, if necessary. She noted that a contingency plan may require relocating the 2018 Obedience Trials outdoors.

DELEGATE'S REPORT

David Helming, AKC Delegate, updated the board about recent dog registration concerns that the board had referred to him and asked him to communicate the board's concerns to AKC. Without objection, the board asked him to continue to communications with AKC in these matters.
