Mary Lou Cuddy moved, and Steve Britton seconded to adopt the agenda. The board adopted the agenda as published and without objection.

The board of directors approved the minutes of its session held on May 3rd, 8th and 9th, 2022 as presented.

Donna Thibault moved, and Lynne Anderson-Powell seconded to approve an agreement with an auxiliary hotel property for the 2023 National Specialty in Frankenmuth, Michigan. The board adopted the motion without objection.

On behalf of the Specialty Show Committee, Steve Britton moved to give permission to the 2023 NCA National Specialty Show to divide the Bred-by Exhibitor Class into two classes; 6 – 12 month Bred-by Exhibitor Puppy Class and 12 month and over Bred-by Exhibitor Class (per AKC *Rules Applying to Dog Shows)* for a one-year trial basis. The board adopted the motion with objection.

Susan Wagner moved, and Mary Lou Cuddy seconded to approve holding the AKC National Owner Handler Series Competition at future NCA National Specialties. (Previously, the NCA Board approved holding the competition on a one-year trial basis). The board adopted the motion without objection.

John Cornell requested postponement to the consideration of National Specialty Catalog page specifications and requirements to the July meeting. No one objection to the request.

Pam Saunders moved, and Steve Britton seconded to enter executive session.
